

INVITATION TO BID FOR THE INDUSTRIAL TECHNOLOGY COMPLEX (MARITIME EDUCATION BUILDING)

- The <u>EASTERN VISAYAS STATE UNIVERSITY</u>, through the GENERAL FUND (GF), intends to apply the sum of <u>Php14,923,212.00</u> being the Approved Budget for the Contract (ABC) to payments under the contract IB-11-0837-17PD. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The <u>EASTERN VISAYAS STATE UNIVERSITY</u> now invites bids for <u>INDUSTRIAL TECHNOLOGY COMPLEX (MARITIME</u> <u>EDUCATION BUILDING</u>) of EVSU-Main Campus, Tacloban City. Completion of the Works is required <u>180 Calendar Days</u>. Prospective bidders should possess a valid PCAB License applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC, and have key personnel and equipment (listed in the Eligibility Forms) available for the prosecution of the contract.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion. All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation (IRR).

- 3. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines. The BAC will conduct post qualification of the lowest calculated bid.
- 4. Interested bidders may obtain further information from <u>EASTERN VISAYAS STATE UNIVERSITY</u> and inspect the Bidding Documents at the address given below.
- A complete set of Bidding Documents may be purchased by interested Bidders on <u>November 22, 2017 November 30, 2017</u> from the address below upon receipt by the BAC of their Letter of Intent (LOI) and upon payment of a nonrefundable fee for the Bidding Documents in the amount of (<u>P25,000.00</u>) <u>Twenty-Five Thousand Pesos</u>.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later that the submission of their bids.

The <u>EASTERN VISAYAS STATE UNIVERSITY</u> will hold a Pre-Bid Conference on <u>December 4, 2017, 1:30 P.M.</u> at <u>Eastern</u> <u>Visayas State University Office of the Vice President for Administration, Conference Room, Tacloban City</u>, which shall be open only to all interested parties who have purchased the Bidding Documents. Site Inspection will follow after the Pre-Bid Conference.

- Bids must be delivered to the address below on or before <u>December 18, 2017, 1:00 P.M.</u> (EVSU Guard House clock time) at <u>Eastern</u> <u>Visayas State University Office of the Vice President for Administration, Conference Room, Tacloban City</u>. All bids must be accompanied by a bid security/bid securing declaration in any of the acceptable forms and in the amount stated in ITB Clause 18.
- Bid opening shall be on <u>December 18, 2017, 1:30 P.M.</u> at <u>Eastern Visayas State University Office of the Vice President for</u> <u>Administration, Conference Room, Tacloban City</u>. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 8. The **<u>EASTERN VISAYAS STATE UNIVERSITY</u>** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
